# Delegate's Report (JoAnn)

- The website has been updated with all things 73<sup>rd</sup> General Service Conference along with information on the Board Chair and trustee resignations.
- Added a new link to service opportunities. It's called "A.A. Want Ads."
  - There is an opening where they are looking for a member for a working group tasked with revising the Pamphlet "A.A. for the Native North American Alcoholic.
- Trustee information updated on websites
- There is a new memo regarding the Grapevine Liability fund. It was sent in English and French only. Will be on the website in spanish soon.
- Meeting with our new Northeast Regional Trustee Ken on Sunday, and I will also attend Asamblea to give a report to the Hispanic Districts.
  - Spanish language books, from NERF will be given away. (names in a hat and give away like I did at our last assembly)
- I emailed member services at the GSO office regarding GSR kits and they want names so they can research it. I believe I received 5 emails from GSRs stating they didn't get their kit and I will get a list of the RSGs on Sunday.
- Last assembly confirmed Rich and Sherry will be the co-chairs for the GSC hospitality committee for the 74<sup>th</sup> GSC.
- As chair of my committee, I get to meet with the chair of the Equitable Distribution of Workload subcommittee which is three-year trial. We have started year 3 and will discuss possibilities of extending the deadline that proposed agenda items are due. It is currently September 15<sup>th</sup>. We are scheduled to meet virtually next Tuesday July 18<sup>th</sup> at 7pm.

Regarding our Area Convention, I have some information to run by you:

- Now scheduled for March 14-17, 2024.
- Waiting to see if another group who reserved March 21-24 is going to move forward with a contract. Will know by the end of the week. John W and JoAnn were able to negotiate some better terms:
  - The room night requirement will be extended over the 3 days instead of each day as a stand-alone requirement.
  - Marriot had \$3000 per year for the facility. We were able to agree to the amounts \$2000, \$2500 then \$3000 for use of the space over the three years 2023, 2024, 2025.
- And most importantly, the room night cost. Last contract was \$137 per night but that was from 4 years ago. For the next three consecutive years the room nights are as follows:
  - o **2023- \$165**

- o **2024 \$175**
- o 2025 \$185
- They promised a 25% reduction on the room night requirement for 2025 due to the international convention.
- They know they have the space we need and there is no other venue in Westchester that compares.
- Requested a quote for the Long Island Marriott and I am waiting to hear back. Similar hotels; Long Island Marriott is larger.
- The Marriotts are now franchised and independently owned and operated. We may get a better rate if the dates are available.
- I will be submitting the agenda item from last year regarding service positions but making it a little more understandable and simpler.
- Anyone who wants to submit an agenda item with the Area's support, you must submit it to me and if the Area supports it, I must be the one to submit it for consideration for you. Let Paola and I know so it can be added to the agenda for our Assembly on September 10.
- On Saturday, I am going to the Not a Glum Prom on Saturday hosted by the YPAAs. I was asked to speak at the AA meeting.
- The NYSIW is coming up in Buffalo from July 28-30 and I am hoping many of you registered and plan to attend.
