## Proposed Agenda Items for 2024 General Service Conference:

## 1. Asian American Pamphlet:

Proposal( Steven): A new Asian/Asian American pamphlet. There's a lot of literature translated from other cultures but not from the Asian Diaspora. Steven has contacted GSO but would like the support of SENY to bring the proposal again. Especially, because of stigma in and out of the community.

#### Q1:

Would this include South Asian, East Asia, or Asia as a whole?

#### A1:

Haven't specified, the most important thing is to have a pamphlet or literature for asians and asian americans to culturally relate to.

#### Q2:

We are a melting pot, but can literature afford to do it? Are we opening up Pandora's box? The stories in the back of the book are meant to be universally relatable.

#### A2:

They don't look at the cost, they look at the need. Also there are cultural differences for asians and asian americans. I don't celebrate Christmas, I have lunar new year, I didn't grow up with baseball.

#### Comment:

I need more information.

#### Comment:

I relate to Steven, I came in very young and there was no one my age in the rooms either. I think having the conversation is valuable. There's no literature for people who grow up in that culture, inclusivity and identification is important:

#### Q3:

Have you reached out to the international desk at GSO?

## A3:

One guy from Nerassa, told him that it's all translated literature, not culturally relatable.

#### Comment:

The agenda item is for a pamphlet. 2021 this was also proposed. Maybe we should go back to GSO to revisit and talk to past delegates to get more details.

#### Comment:

Is this divisive? No, will it make the message more accessible. Is there demand? Yes, see Steven and also zoom has connected a lot of diverse communities. Understand that it's a diverse community, but look at the LGBTQ.

## Q4:

This came up at Manhattan Share a day. Have we looked at the grapevine to get them to reach out to more communities, ASOM (?)

#### A4:

I haven't, but I'd be willing to do that as well.

## Comment:

I'd just like to point out if we're talking about an Asian American pamphlet, we didn't consider all dialects of Black people in Africa.

## Response:

We can start with English.

## Q1:

For the newcomer. I've heard a few people talk about leaving a meeting and not having a cover, the bright yellow and red book is very noticeable.

#### Comment:

\*takes the big book cover, turns it to the blank side and puts it back on, shows reverse cover\* That makes it anonymous.

#### Q2:

I'm not sure I understand what the issue is?

## JoAnn(answer):

At one point there was a delay in getting the jackets so they decided to print it directly on the book. Camille: At events, when we walk past the table, how are we selling the literature and how are literature chairs going to organize?

#### Q3:

Sorry, I still need clarification.

#### Comment:

We have all these anonymous softcovers. Why not keep the hardcover at home?

#### Comment:

A lot of people are reading online, the hardcover stays at home, people who want options have options available.

#### Q4:

If we have an anonymous cover, how can we distinguish between any other book on a bookshelf?

#### A4:

The name is still on the spine so organizing isn't a problem. The yellow and blue hardcover is bright. We want to make the hardcover look like the blue softcover with an imprint of the title.

#### Comment:

I know initially the new editions came out with the anonymous cover, but are we looking to make a change based on a one time supply issue.

#### Comment:

I had that newcomer experience of not wanting to take the book. The yellow and bright is a little too much.

#### Comment:

I had a cover until I felt comfortable. Someone next to me could still see what I was reading.

Q2:

Would it contain a generalization of these commitments? What's the scope of commitments? Conventions? YPAA? Board? Service below group level?

#### A2:

All of this. The details have to be worked out, but ideally it should include all of it.

#### Comment:

How can we outline all the requirements? I'm not sure we can, so I'm against it.

#### Comment:

A lot of people have no idea about service, not sure if a pamphlet would make a difference, but a lot of groups are not even active in service outside of the group.

#### Comment:

At meetings I often see a lot of people perusing the pamphlets and maybe if they see a pamphlet about service they'll ask their sponsor about service below the group level. We need more people to participate. Right now people stay in the same position for 20 years.

#### Q3:

I'm just wondering why we aren't asking GSO to do this instead of taking it on ourselves.

#### A3:

I'm just looking for approval to bring to and propose.

## Comment:

I think it's a great idea.

#### Comment:

If there had been a pamphlet I may not have agreed to do service, but I think its a good idea.

#### Comment:

Good idea, but maybe we take it on in the area without a test market and show them after a year or so that it works. There are too many nuances nationally, there's a better chance of getting it approved if we have a prototype.

#### Comment:

I'm hesitant to include the word 'text" because it has broad implications.

#### Comment:

F-20(?) This issue has been addressed.

#### Comment:

Someone came up to me and knew my name, randomly and I found out that someone had posted all people and their service positions in a FB group.

#### Comment:

This just seems like something we should be addressing at the group level.

Comment:

I realize we've tried before but why not try again?

#### Comment:

Spanish groups ask why it doesn't say that, but we understand what public level means. It's up to us to respect the spirit. It's impossible to foresee where technology will go and we really have no idea what we'll have next.

#### Comment:

It's simple, that could go on ad nauseum with changing technology. We should leave it up to the members to respect the traditions.

#### Comment:

It may be good to propose it because even if tradition isn't changed at least people are at least talking about it.

#### Comment:

I think respecting this tradition is important and AAs should be reminded of this.

## 5. AAWS templates/IP

Proposal (Mike): Ask GSO to provide access to software, licensees, watermarks to use on various service entity websites to address mis/disinformation on the web, for example alcoholicsanonymous.com is not owned by AA and sends people to a site which advertises rehabs and other profit making organizations, to clarify what is AA and what is not AA.

#### Comment:

I've had this concern before, but want to hear everyone else's opinion

#### Q1:

So how does having the IP help?

#### A1:

The real goal is to watermark area or intergroup websites –all of these websites are local. In the sameway when I see a big book I know it's AA, I'd like something that when you look on a website you know it's AA so it does not appear that we are affiliated with what non-AA organizations chose to advertise on their sites.

#### Comment:

Maybe we should just be bringing this to GSO legal

- "...allow legitimate sources to use IP/graphics/text without fear of reprisal"

#### Comment:

I've been on the AA.com website by accident, it has things on it that ask for money, I think it's a legitimate problem

#### Comment:

I have an issue with the word "legitimate" AA entity. The answer maybe shouldn't be a regulation.

What do we consider an AA event? YPAA and Alanon technically aren't affiliated. How do we define AA events?

#### Comment:

What is the fellowship of the spirit? Is it christian? They aren't organizations but they are members.

#### Q1:

While we don't endorse or affiliate we do foster cooperation. Who do we cooperate with, how would you operationalize this proposal?

## A1:

I'm not sure. I'd go back to the bottom line and just say it appears that we are affiliating with some entities.

## Q2:

What about Manhattan-Share-a-day?

#### A2:

I'm specifically addressing the grapevine and AA calendar.

#### Comment:

I think it's hard to differentiate and we should be careful with this one.

#### Q3:

We're voting to bring it up as an agenda item?

#### A3:

if it were voted for then it would be enforceable and Grapevine and GSO would enact it.

#### Comment:

I thought it was a mistake to include certain events but they continue to do it.

#### Comment:

I looked up events and a flyer pop-up with a speaker advertising the Dr.'s books.

#### Comment:

According to Box 459 shows the spirit and feeling behind the conference, but grapevine doesn't go through the same channels.

So it's an event formed from AA entities?

#### A4:

Not sure if it explicitly says 'AA entities', that language is not confirmed.
